CREATING DEALER SOLUTIONS

For dealers who want to meet the highest standards, Continental Engines has a service dealer program that will work for you. Participation in one of the following programs will establish a dealer relationship with Continental Engines. This will enable the dealer to purchase Hatz engines and parts at a discount, provide warranty coverage, effectively carry out repairs. and have access to educational/training benefits.

The tj tgg types of dealer programs offered by Continental Engines:

- Bronze Dealer
- ➢ Silver Dealer
- Gold Dealer

Each of the above dealer classifications will be authorized to provide service for certain Hatz engine lines. The following is an overview of requirements and benefits for each dealer classification.

CRITERIA FOR BRONZE DEALER

This program is designed for the dealer who wishes to perform service and warranty for Hatz Mechanical Air-Cooled engines, ONLY. The Bronze Dealer will be able to purchase Hatz engines, parts, and accessories at Bronze Dealer discount level. This dealership type requires a level of training and tooling specific to the engines serviced.

BRONZE DEALER REQUIREMENTS

- 1) Signed Authorized Hatz Bronze Dealer Service Agreement.
- 2) Must have sufficient service facilities and capabilities to service Hatz Mechanical Air-Cooled engines.
- 3) Service technicians must complete a factory authorized training course within one (1) year of becoming a Bronze Dealer.
- 4) Purchase order for initial Continental Engines Bronze Dealer start-up package. Form #85250018.
- 5) Attend Hatz training/service schools provided by Continental Engines or Hatz Diesel of America; minimum attendance once every three (3) years.
- 6) Ability to file warranty claims via Hatz electronic E-warranty system.
- 7) Registration of the Hatz Diesel on-line parts catalog (EPO) system.
- 8) Must provide Continental Engines with proof of posted labor rate annually. Form #AHSD-ASLR001.
- 9) Maintain an adequate inventory of Hatz Mechanical Air-Cooled engine parts.
- 10) Display Hatz Bronze Dealer Signage in the Dealership.
- 11) Special Tooling; please reference the Hatz special tool catalog, individual engine repair manual and Hatz recommended tool list.
- 12) Mobile Service Capabilities (Preferred).

BRONZE DEALER BENEFITS:

- 2) Discount of 10% off Hatz published list prices on replacement engines.
- 3) Discount of 15% off Hatz Diesel published list prices on spare parts and accessories.

CRITERIA FOR SILVER DEALER

This program is designed for the dealer who wishes to perform service and warranty on Hatz Mechanical and Electronic (E1) Air-Cooled engines ONLY. The Silver Dealer will be able to purchase Hatz engines, parts, and accessories at the Silver Dealer discount level. They will also be able to perform warranty service on all Hatz Air-Cooled engines. This dealership type requires a level of training and tooling specific to the engines serviced.

SILVER DEALER REQUIREMENTS

- 1) Signed Authorized Hatz Silver Dealer Service Agreement.
- 2) Must have sufficient service facilities and capabilities to service Hatz Mechanical and Electronic (E1) Air-Cooled engines.
- 3) Service technicians must complete a Hatz Factory Mechanical and Electronic (E1) Air-Cooled engine training course before becoming a Silver Dealer.
- 4) Purchase order for initial Continental Engines Silver Dealer start-up package. Form #85250224.
- 5) Attend and complete Hatz training/service schools provided by Continental Engines or Hatz Diesel of America; minimum attendance once every two (2) years.
- 6) Ability to file warranty claims via Hatz electronic E-warranty system.
- 7) Registration of the Hatz Diesel on-line parts catalog (EPO) system.
- 8) Must provide Continental Engines with proof of posted labor rate annually. Form #AHSD-ASLR001.

The Gold Dealer will be able to purchase Air and Liquid-Cooled engines, parts, and accessories at the Gold Dealer discount level. They will also be able to perform warranty service on all Hatz Air and Liquid-Cooled engines. This dealership level requires a high standard for training, tooling and adequate parts stocking requirements specific to the engines serviced.

GOLD DEALER REQUIREMENTS

- 1) Signed Authorized Hatz Service Dealer Agreement.
- 2) Purchase order submission for initial Gold Dealer start up package. Form # 85250219.
- 3) Must have sufficient service capabilities and facilities to service all Hatz Mechanical and Electronic Air and Liquid-Cooled engines.
- 4) Service technicians must complete a Hatz Factory Mechanical and Electronic Air and Liquid-Cooled training course before becoming a Hatz Gold Dealer.
- 5) Attend Hatz training/service schools provided by Continental Engines or Hatz Diesel of America, minimum attendance every two (2) years.
- 6) Ability to file warranty claims via Hatz electronic E-warranty system.
- 7) Registration of the Hatz on-line parts catalog (EPO) system.
- 8) Must provide Continental Engines with proof of posted labor rate annually. Form #AHSD-ASLR001.
- 9) Maintain an adequate inventory of Hatz Mechanical and Electronic Air and Liquid-Cooled engine parts.
- 10) Display Hatz Gold Dealer Signage in the Dealership.
- 11)Special Tooling; please reference the Hatz special tool catalog, individual engine repair manuals and Hatz recommended tool list.
- 12) Mobile Service Capabilities (Preferred).

Applicant agrees to pay, upon demand, a late charge of 1.5% per month (A.P.R. 18%) for all invoiced amounts that have not been paid within thirty (30) days from the invoice date.

Should Continental Engines refer any past-due balance to any attorney or collection agency for collection efforts, Applicant agrees to pay, upon demand, a collection fee equal to 33% of any sums due from Applicant together with any other fees, costs or expenses incurred to collect the past-due balance, including court costs. This document and all disputes shall be governed by the laws of the State of South Carolina.
